

Terms and conditions for 'Resolve Finance - Aintree home loan promotion':

1. Information on how to enter and prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

Resolve Financial Solutions PTY LTD trading as Resolve Finance (ACN 079 545 378, Australian Credit Licence 385487), Resolve Finance Management Pty Ltd (ACN 120 846 540) is not the promoter of the campaign and is in no way involved in or liable for this campaign.
3. Entries are open to Australian residents aged 18 years and over who engage with Resolve Finance - Aintree between and successfully settle a home loan using Resolve Finance – Aintree.
4. Employees (and their immediate families) of the Promoter, Resolve Franchisees (including admin staff), Resolve Brokers (including admin staff) and agencies associated with this promotion are ineligible to enter.
